State Environmental Policy Act - Purpose

- SEPA process identifies and analyzes environmental impacts associated with governmental decisions
- Helps agency decision-makers, applicants, and the public understand how the proposal will affect the environment
- Utilizes a systematic, interdisciplinary approach

Ensures that environmental amenities and values will be given consideration in decision making

SEPA - Process

> After review of the proposal, lead agency issues either:

Determination of Nonsignificance (DNS), which may include mitigation (MDNS) OR

Determination of Significance (DS), if the proposal is likely to have significant adverse environmental impacts

Requires an Environmental Impact Statement (EIS)

The EIS process - a tool for identifying and analyzing probable adverse environmental impacts, reasonable alternatives and possible mitigation measures to reduce environmental impacts

Provides for other agencies and the public to participate

Environmental Impact Statement - Process

SCOPING

- The scoping process allows the public and other agencies to comment on the EIS scope - alternatives to be evaluated, assists in identifying issues and concerns
- > Determines what will be included in the Draft EIS "the Scope"
- Will inform subsequent contract scope

DRAFT EIS

Analysis of environmental impacts, alternatives, another opportunity for agency and public involvement

FINAL EIS

Environmental analysis to be considered in decision-making

Zenith Properties LLC Proposal

- Zenith Properties has applied for a demolition permit for structures located at 23660 Marine View Drive S (formerly known as Landmark on the Sound)
- City is required to process and review the application in accordance with applicable regulations
- State Environmental Policy Act (SEPA) review is required for the proposal
- City reviewed application and requested additional information, primarily related to cultural resources
- City is preparing to issue a Determination of Significance (DS) requiring an Environmental Impact Statement

City's Role

Administrative review process for the permit application

- City Council tonight: to approve resources for consultant services
 - > The action tonight is not a decision on the permit application
- City is in a regulatory role
- Review proposal for code compliance
- Conduct appropriate environmental review, EIS
 - Public involvement process
- Permit decision will not be made until completion of the EIS process

City's Role – EIS

Administrative Process prescribed by Des Moines Municipal Code

DMMC 16.05.160(1)

Preparation and content of draft and final EISs (DEIS and FEIS)....is the responsibility of the Planning, Building and Public Works Department under the direction of the responsible official.

DMMC 16.05.160(2)

The Planning, Building and Public Works Department shall contract with consultants as necessary for the preparation of an EIS. <u>The cost of preparing an EIS shall be borne entirely</u> by the applicant.

DMMC 16.05.160(4)

The Planning, Building and Public Works Department shall interview the candidate consultants, select the most qualified consultant and negotiate a contract for services.

- Public involvement plan and implementation
- Applicant is responsible for the costs of the application processing, including the SEPA process and EIS
- Consultant will work at the direction of the City not the applicant
 - Sub-consultant experts will complete technical analysis and/or peer review of applicantsupplied information
 - Examples: Cultural and structural reports, archaeological survey, cost analysis, outreach materials

Summary

The City is required to review the application and complete Environmental Review The action tonight is not a decision on the permit application

- Approve the contract for consultant experts to assure a rigorous environmental analysis and robust public involvement process
 - Subject matter experts sub-consultants

OR

City staff will complete the EIS without ESA expert consultant assistance
