1. Call to Order/Roll Call

#### 2. Consideration of May 5, 2022 PSEM minutes

#### 3. Summer Events Update: Commander Richards

- Planning for staffing of the Water Land parade, 4<sup>th</sup> of July Fireworks event and other summer events.
- City Staff has been great helping PD getting everything ready: adding fencing, parking issues, and traffic control.

#### 4. Flock Camera Update: Assistant Chief Couey

- Described flock camera program, designed to capture rear of vehicle for license plate to capture stolen vehicles
- Described as an effective tool to find stolen cars, and various crimes

#### 5. Animal Control Update: Commander Richards

- Contract with Burien CARES and scope of work has been reviewed by all and will be a City Council agenda item for next week
- Detail of contract includes: a dedicated trained animal control officer, after hours provision, 40 hours dedicated service, shelter services, engagement with residents, will be a limited commission to write citations

#### 6. Crisis Response Specialist: Commander Richards

- PD has hired a crisis response specialist with a background in helping individuals in crisis
- She is training and has helped several individuals in need
- She is developing communications and helping individuals navigating processes

- Pierce College Capstone Project Description
- Project Director asked if her 17 EM graduates could create EOC tasks books and position descriptions for EOC
