It seems that the misinformation emanates from city council. It is specious reasoning for city manager Mathias to imply that the study of license plates on cars visiting the marina showing that 80% were from outside of Des Moines is evidence of our city being a major tourist destination and therefore could support a hotel. And for Mr. Mathias to follow up that remark with the anecdote of a visitor who flew into SeaTac and rented a boat as another example of the support for building a hotel right by the water is irresponsible.

Hello again. My name is Eldon Davis. I spoke at the last Council Mtg re Hotel and Retail Spaces at the Marina.

Today I will be expressing thoughts re the proposed Creek along 223rd and Steps going down to the Marina. And sorry, this version has a few different words, but overall content is the same.

A. Creek Along 223rd - Note 223rd being only 1 of 2 ways to reach the Marina by car.

- 1. Where along 223rd will creek begin and end?
- 2. What will happen to the creek once it nears the end of 223rd?
- 3. How will the underground water East of the creek starting point get to the starting point?
- 4. How wide and deep will the creek be and estimated speed of the flow?
- 5. Will the creek have some form of covering or be open and if open what will prevent people, animals, and trash from going into the creek?
- 6. How will the people in the large condo on north side of 223rd and west of 6th, get in and out of

their parking area if creek is along that part of 223rd?

B. Marina Steps

1. Why is the concept called steps instead of walkway or better yet, Marina Access Walkway?

2. How much distance between where creek ends and steps/walkway begin?

3. What ADA requirements will be incorporated: slope of 8.33%, a 5'x5' level platform every 30' of

length, 5' of width, handrails on both sides, and probably some specified surface mat'l? 4. What will be the underneath support for approx 420' of stairs/ walkway and 70' of level platforms

zig - zagging down: will it be fill dirt or vertical columns or something else?

5. If people come to the steps by car, where will they park as their is essentially no space?

6. How much area (length x width) below the cliff will be needed by the steps/walkway?

7. Estimate of what % of people walking down will not have energy to walk back up?

Concluding thoughts: The area at the top of 223rd and near the cliff seems to be very congested and a negative impact on cars wishing to get to the Marina. Re the steps / walkway, the name of

Marina Access Walkway seems more appropriate and for some this may be a scary venture.

8. How much distance between the end of the creek and beginning of Steps/Walkway?

9. Estimate of % of people going down will have the energy to walk back up?

Thank you city council members,

I appreciate your service and work you do for Des Moines. I know that you are aware of how important the marina and surrounding area is to Des Moines. This area serves as the primary economic driver and community center for Des Moines and draws people from a wide area. The north parking lot adjacent to the pier enables people of all ages and abilities to enjoy the stunning natural beauty of Puget Sound and connect with the natural environment. For many seniors, the disabled and for those with young children parking availability is a key determinant in their ability to experience this. People protect what they love and people love their marina and pier access and as a result they love Des Moines. For many people in surrounding communities the marina is Des Moines. Doing anything that degrades the marinas appeal to visitors from the local community and surrounding areas should be avoided.

You have received many comments from the community regarding redevelopment of the Des Moines marina. These comments show that most community members do not support plans to build a hotel in the north parking lot adjacent to the fishing pier. Following through with these proposed plans would cause a lot of harm to residents, visitors and local businesses in the hope that there would be some benefit (but many think that benefit is marginal and/or questionable at best) Building a hotel in this location could also open Des Moines up to liability due to potential engineering concerns. If a hotel is to be built I believe better options could be found that would provide a clearly defined benefit to the community while reducing harms.

The comments received show that there is a need for a planning commission to fully investigate development of the marina. A city planning commission could help obtain important information for the city council and work along with community members to help avoid potential pitfalls. The decisions that council makes are only as good as the data they are based on. It is unfair and unwise to expect council to have sole responsibility for investigating planning issues and disseminating this information to community members. I also think it is important to be fully transparent when choosing a developer. There should be a sufficient window of time (as determined by council, the planning commission and community members) for multiple developers to submit proposals. Development and improvement of Des Moines are responsibilities that council must share with community members if those efforts are to be successful.

I am all for continued gated parking to the Des Moines marina, frequent user parking passes and special parking permits for fishermen to park after 10pm. I think these programs make the area safer and provide needed revenue. I would also support more outreach and information on how these revenues are being used to upgrade the marina and possibly an easy pay what you can option if people want to pay more towards these goals. If there was an easy option to donate to a fund with a

tax write off receipt it might help generate additional revenue for fixing the marina fishing pier and dry dock boat launch.

I would like to see the quarterdeck and the marina offices remain at the central marina location. It is important that services are easily accessible to visitors of the pier and north parking lot as well as the marina slip residents. This location is important and serves as a safe presence in the area. These facilities, the foot traffic and the open visibility condo owners have of the area helps deter crime. The quarterdeck is an essential venue for summertime performances and a community hub and should be considered part of the marina waterfront area.

I would like to see more pedestrian friendly small shops and restaurants along and adjacent to marine view drive. The marina provides an ideal location to enjoy local take out. I would like to see this area become the pedestrian centered draw that I know it can be. (It's good now but it could be great.) Development occurring in the downtown core should be pedestrian friendly, provide for everyday needs of local community members and options for entertainment for locals and visitors alike.

I believe that safety will continue to be a primary concern for residents and businesses. The smart cameras along pacific hwy were a great investment. I believe that continued support for these types of projects will encourage new businesses to come to Des Moines and help existing businesses flourish in comparison to areas that don't make these types of investments.

Thank you for providing the insightful history of the marina, much appreciated as I've only lived here since 2009. I also found the architect's presentation extremely interesting, regardless of how much of it is eventually deemed feasible.

I want to offer my impressions on the dynamics of your relationship with the city councilmembers. With 30 years as an Executive Director and 9+ working for city government (Kent), I know what it's like to have obstinate "squeaky wheels" who challenge virtually everything you are passionate about accomplishing. But you *need* them to be there. They will ultimately help the city make decisions that are financially sound, pragmatic and in the best interests of our diverse community.

The animosity is I felt at the meeting was palpable, bordering on toxic. Councilmembers Achziger and Harris are deeply frustrated and for good reason. They are not receiving background information PRIOR to critical meetings and are expected to digest and vote based on plans with no financial, environmental, economic* or community impact to back them up. (*Yeah, about that Oxford study, is the Marina Inn driving the economy up?) A feasibility study will reveal all this, of course.

You mentioned the "insanity" quote. Well, here's another: "Good management without good leadership is like rearranging deck chairs on the Titanic." Your councilmembers are the elected leaders and you are the manager. For them to lead, they need to be provided the courtesy and respect they deserve. There was ample opportunity to provide them with the presentation materials in advance (the public, too, via the website), so we all arrived understanding where we were and dispelling the misinformation some have been laboring over. That's my first suggestion.

2. Every councilmember expressed sincere appreciation to us for coming. It is obvious to them that the community cares and will turn out for things that are important to us. Therefore, I ask the city councilmembers as our leaders to insist on a planning commission that will give us a continuing voice in marina development. I would be proud to serve on it and I know many others who would, too. As one speaker put it, reach out and use us. We are educated and invested.

3.Since it appears the city has not been able to buy out the ugly vacant "pit" on Marine View Drive, can you invest a fraction of that money in disguising it by removing the unsightly chain link fence and installing one that could give artists an opportunity to create a mural (or several) to enhance the drive through our business district.

I watched the entire meeting last week and have been keeping updated for several years. I live above the Marina at Cliff Ave S. And S 223rd so am directly impacted by your decisions. Thank you for reading this and I suspect hundreds of other comments. mine will be directly related to the effects it will have on me and my home (a huge investment!)

I first would like to say that the City Manager's repeated comment that the beach park is used by 80% of people from out of town did not reflect any data to so that is true. Don't giv information like this unless you can support it with fact.

STAIRS:

WHY spend millions of dollars on concrete when accessibility is so limited by lack of parking above? Only the physically able can and will use. Being retired I see the pedestrians go up and down the street to the park and Marina daily either on the sidewalk or in street but rarely is there one with physical issues. Crossing 5th Ave S is not ADA compliant per the city traffic department so why not make it so?

The architects and council did not even mention the impact on the immediate residents including NOISE, PARKING, TRAFFIC. including speeding up and down Cliff Ave and more. I see and hear this daily and I believe you are avoiding this issue to try to "sell" this plan. What about environmental impact? There is already noise issues with the Quarterdeck having music gigs every week when weather permits!) It is a huge issue with affected residents. None of the architects have said they live in this immediate area? You are trying to make this a regional magnet instead of focusing on what is best the for Des Moines residents! HOTEL:

Dear Des Moines City Council,

I appreciate the opportunity to see the study session with you yesterday. It was very helpful to have a review of the history and planning that has occurred, as well as to learn that the hotel that was presented in November was merely a concept, and by no means a done deal.

As Mayor Mahoney said at the start of the meeting, the definition of insanity is "doing the same thing over and over and expecting different results." I looked up the term and found it also means "extreme foolishness or irrationality." Which is how citizens felt about the council's decision making - when after years of process about preferences for the marina and downtown with politicians assuring us that view corridors would be respected - then to have a sudden switch to putting a hotel by the pier impacting views of 100's of residents who live next door to the marina, and taking premium public waterfront space.

I support creating more waterfront park space on the north parking lot. The proposed parking structure for Parcel A would net 56 spaces, if 100 parking spaces in the north lot by the pier were turned into more green park space (ground level, not on top of a hotel). Fast ferry commuters would require more parking, so that is a win/win.

When we bought into Waterford Condos in 2015, we quickly learned about the history of city mismanagement of resources and a crisis that politicians wanted to sell off the beach park to a hotel developer. In 2017, the Argosy "dot" project resulted in showing public preferences for a boutique

hotel along with most retail business to go up on Marine View Drive and 7th Avenues in the downtown corridor. Those are the most appropriate places from the standpoint of available space, access to other businesses, and to preserve public waterfront community gathering space. In order to become a destination community, we need to keep the marina and waterfront parklike, not full of buildings. My favorite destinations are Cannon Beach and Leavenworth; both have lots of hotels walking distance from a central downtown with shops and restaurants; and are walking distance from the beach or river. **Des Moines has many vacant lots in the downtown corridor between 223 and 227th, so creating a downtown destination is achievable with the right vision and effort to attract developers to that area of the Marina District, without building out the north parking lot section, or other parts of the Marina or beach park.**

After hearing last night's presentation, I am wondering why the Council decided it would not consider selling off property by existing condos (Parcel A and Marina Steps areas) to a developer to build more condos? That seems to meet the criteria of the Council being charged with adding more housing. During last night's session a comment by a presenter indicated housing was the sweet spot for development. Residents living next to the marina are in a high density, bedroom community. Our buildings were approved by former city councils to be water view properties. An 1,800 sq ft unit with new construction should sell for over a million and bring in \$11,000 in property taxes, per unit. The footprint of the Parcel A section next to the Cliff and Mariner (in line with Dock Avenue) is ideal for more condos which is consistent with current development and does not impact existing parking spaces, or views.

I loved seeing Skylabs waterfront promenade concepts and wish that was where the energy about marina rejuvenation was, instead of wanting to build the \$3 Billion dollar Marina Steps. It is

interesting to see the emphasis about water runoff treatment for 223rd street, and then to see that it is not the only area where ground water in the city runs untreated into the Puget Sound. It seems

odd efforts to treat groundwater runoff would not be consistent across all 6 or 7 creeks/drainage areas.

REMARKS TO DES MOINES CITY COUNCIL MEETING: February 2, 2023 SUIBJECTS:

- A. HOW DOCK AVENUE SOUTH IS A FACTOR IN MARINA DEVELOPMENT
- B. RE-CONSTITUE THE CITIZEN ADVISORY COMMITTEE/BOARD
- C. IMPROVE THE MARINA, BUT FIRST DEVELOP DOWNTOWN

I Dock Avenue South is a major factor in Marina Safety.

It is the only means of back-up emergency vehicular access to the North end of the Marina, the Beach Park, the Harbormaster Building, the Quarterdeck, the boat moorages at the north end of the Marina, and potentially, the condominium buildings along the border of the Marina floor.

If either the Adaptive Purpose Building, the Marina Steps, or the Stormwater Project from South 223rd Street results in blocking off Dock Avenue South, then there will be no secondary emergency access to the Beach Park and their numerous wooden buildings and no access to the north Marina Parking Lot. If an accident or a land slide or a wash out or other catastrophic event results in Cliff Drive becoming inaccessible (all the way from 6th Ave South to the intersection with Dock Avenue), then there is no means of egress or ingress to the Beach Park or the north area of the Marina. I would note that there is also a major sewer pumping station located just within feet of the intersection of Cliff Drive and Dock Avenue. Without Dock Ave., the north Marina Parking lot might not be available to stage emergency services in the case of a Tsunami or other event.

At the very least, Dock Avenue must be kept open all the way from the area of the south Marina entrance to the north Marina entrance and this also means that it should also remain open wherever the Adaptive Purpose Building is located. This is not what the Skylab Representative had in mind at the Study Session last week, as he proposed butting the Adaptive Purpose Building hard up against the Bank that supports the South Shore Condominium. The Adaptive Purpose Building will be full of boats that carry fuel and other combustibles and both it and any other building in the vicinity should be readily accessible to firefighting resources.

The best route for Dock Avenue is in its present location which would take it between the Adaptive Purpose Building and the South Shore Condominium and takes it along the edge of the existing bank.

- II The Council should re-constitute the Citizens Advisory Committee/Board in order to get input on their varying proposals for Marina Development, for <u>Downtown Development and for development in all other parts of the City.</u> There should be representatives from the Marina District, from the Downtown businesses and from all the outlying neighborhoods in Des Moines. As of now, the only input to the Council that is made public is coming from our Citizen Remarks at the Council Meetings and correspondence to the Council from Citizens. We want to be heard in a public forum where a record is made of everyone's remarks.
- III The City Council should put more emphasis on developing the businesses in down town Des Moines, <u>before</u> trying to develop the Marina as a way to lure the public to the downtown. Remember the remarks last week by the restaurant owner who said that people will come if there is something here that is worth of getting to., but he didn't feel that right now, there are enough businesses that people want to patronize. If we have a more lively and vibrant down town and give our business more visibility, then people will want to make this a destination. We need more projects like the theater renovation. We need the commercial landowners to participate so we can consider putting a hotel in the upland area in one of the many under-utilized parcels of property away from the marina, such as the vacant lot across from Wally's. Also, I think that we need to work with our

commercial landowners to consider how to move the stores and restaurants at the north-end, up to street level so they are more visible. Most people drive by and never see Jack's County Kitchen and All Points Yarn. They should all be up on Marine View Drive where they are readily seen. We probably also need to divert and discourage vehicular traffic on Marine View Drive so that more foot traffic is encouraged. Maybe this will be helped by the 509 bypass. Finally, we need to attract a modest sized super-market at the north-end of town in the vicinity of the old QFC store where it is readily accessible to the Wesley residents and others.

• Pediatric Interim Care Center answers a crying need in our community -the danger and distress faced by babies who come into life affected by drugs their mothers took during pregnancy. Located in Kent, PICC's Newborn Nursery is the only facility providing safe shelter and 24-hour nursing care for drug-exposed infants in Washington State.


Drug-Exposed Infants

• Infants born suffering the effects of prenatal drug exposures are the forgotten victims of the crisis for drug addiction affecting our community. The Puget Sound Region continues to confront high levels of use of heroin and prescription opiates, now often in combination with methamphetamine and other drugs. Without intervention, these newborns can be at risk for seizures and other complications of withdrawal, malnutrition, dehydration, failure to thrive, abuse, and neglect.



Infants are referred to PICC by hospitals throughout Washington State, but primarily in the Puget Sound Region. PICC provides transportation from the hospital to the center and to any medical appointments during their stay, which averages 37 days. Throughout that time, they receive 24-hour specialized care by PICC's experienced nursing staff.





Medical Supervision

Medical care is supervised by Dr. Peyton Gaunt, a board-certified pediatrician and PICC's Medical Director. Dr. Gaunt examines the babies on arrival, makes regular rounds to check on their progress, and is on call 24/7.

Therapeutic Handling

• A common symptom of prenatal drug exposure is hypersensitivity to stimuli. PICC provides a soothing low stimulus environment and specialized handling techniques that help the babies rest and recover. For example, snug swaddling controls tremors and helps the babies relax.



Narcotic Assisted Withdrawal

 Babies experiencing a difficult withdrawal from heroin and other opiate drugs may need medication to help them through their distress and allow them to eat and sleep.
 PICC uses small oral doses of neonatal morphine, which are slowly decreased while carefully assessing the baby's symptoms.
 This can take a month or more.



Feeding Difficulties

Babies exposed to methamphetamine and cocaine often lack the trigger that tells a newborn baby it's time to be hungry. As a result, they don't wake to be fed and will only take a small amount when you try to feed them. It takes a lot of experience and patience to help these little ones overcome their feeding difficulties.





Family Services

• PICC welcomes parents to visit their baby daily and learn how to care for any special needs they may have. When baby is ready to go home, we provide infant supplies, caregiver training, and six months of home follow-up. Placement decisions are made by the state. About half of the babies go home with a parent or relative, and about half go to foster care.


Motion: "I move to approve the Proclamation recognizing February as Black History Month."

Background

The roots of Black History Month began with African American scholar Carter Woodson. Throughout his academic studies in the early 20th century, Woodson witnessed how Black people were underrepresented in books and scholarship that shaped the study of American history. To respond to this, Woodson and Jesse E. Moorland founded what would become known as the Association for the Study of African Life and History. Woodson famously asserted that "If a race has no history, it has no worthwhile tradition, it becomes a negligible factor in the thought of the world, and it stands in danger of being exterminated."

In 1926, Woodson and his organization launched "Negro History Week" to highlight the need to teach Black History. They chose the second week of February since it encompassed the birthdays of both Frederick Douglass and Abraham Lincoln.

Throughout the Civil Rights Movement of the 1960's, the celebration of the week was adopted by many Freedom Schools in the South, and then that week was adopted and expanded into "Black History Month" on college campuses. President Gerald Ford proclaimed Black History Month a national observance in 1976.



Proclamation

PREAMBLE

"History, despite its wrenching pain, cannot be unlived; but if faced with courage, need not be lived again." [Maya Angelou, author]. One's history is a fundamental aspect of one's cultural experience. To deny one's history, or to have others deny one's history creates a falsehood as to the nature of one's experience. "Defining myself, as opposed to being defined by others, is one of the most difficult challenges I face." [Carol Moseley-Braun, first black female U.S. Senator].

The celebration of Black History Month is a recognition across this country of the experience and events occurring in the lives of African Americans and those whose roots run deep through the African Diaspora. "For I am my mother's daughter, and the drums of Africa still beat in my heart." [Mary McLeod Bethune, educator]. Acknowledgement of Black History points out that no one culture, no one race, possesses claims to be the dominant history of our nation. It is a shared history, seen through many different eyes.

In these days that have presented the challenge of America accepting the truth that Black Lives Matter, it is all the more important to honor Black History and the innumerable contributions made by African Americans. History, seen through the eyes of people of color, reveals an America that engenders hope for justice, but also retains strong currents of endemic racism.

WHEREAS, Black History Month is celebrated in recognition of achievements and contributions made by African Americans and all people of African descent in the United States; and

WHEREAS, Black History Month affords special opportunity to become more knowledgeable about black heritage, and to honor the many black leaders who have contributed to the progress of our nation; and

WHEREAS, such knowledge can strengthen the insight of all our citizens regarding the issues of human rights, the strides that have been made in the crusade to eliminate barriers of equality, and the continuing struggle against racial discrimination, injustice and poverty; and

WHEREAS, the City of Des Moines embraces its diversity and acknowledges the invaluable contributions of its African American residents and visitors as we celebrate Black History Month; and

NOW THEREFORE, THE DES MOINES COUNCIL HEREBY PROCLAIMS and recognizes the month of February as **BLACK HISTORY MONTH** and urges our citizens to join together in making this period of rededication to the principles of justice and equality for all people.

Purpose and Recommendation

The purpose of this agenda item is for the City Council to consider Draft Ordinance 23-003 which would amend chapter 19.12 DMMC to add the Redondo Boardwalk and adjacent City-owned tidelands to the area that encompasses Redondo Beach Park. The following motion will appear on the consent calendar:

Suggested Motion

Motion 1: "I move to suspend Rule 26(a) in order to enact Draft Ordinance No. 23-003 on first reading."

Motion 2: "I move to enact Draft Ordinance 23-003, amending chapter 19.12 DMMC to include the Redondo Boardwalk and adjacent City-controlled tidelands within Redondo Beach Park."

Background

The City of Des Moines Parks, Recreation, and Senior Services Master Plan identifies over 40 parks and open spaces within the City spread over 162 acres throughout the City held for the public for recreational purposes. Since its annexation in 1997, an important piece of the system is Redondo Beach Park, located in the heart of the Redondo neighborhood on the shores of Puget Sound. The park includes a boat launch ramp, a public fishing pier, beach access, restrooms, public art, and parking for users of the park and the boat ramp.

Extending south from Redondo Beach Park, located along the west side of Redondo Beach Drive South, the Redondo Boardwalk is a pedestrian walkway constructed on a seawall to replace the prior boardwalk that was critically damaged by a winter storm in fall 2014. Due to its location overlooking the beach with stunning views of Puget Sound running much of the length of the Redondo waterfront, the Boardwalk is an integral part of recreational activities centered on Redondo Beach Park and a host to recreational activities of its own. The Boardwalk also contains multiple points of access to the tidelands lying just west of the Boardwalk.

Discussion

The proposed Draft Ordinance will codify what is already perception – that the Boardwalk is a recreational facility that is functionally a part of the City's waterfront park at Redondo. It is an ideal area for exercise, dog walking, beach access, viewing Puget Sound, and other forms of recreation. The City also owns and/or controls tidelands currently outside Redondo Beach Park that are dedicated for public use. The proposed Draft Ordinance would bring these parcels within the park as well.

Reconstruction of the Boardwalk following the 2014 storm event was funded in part through transportation grant funding, so the proposed Draft Ordinance recognizes that the Boardwalk is primarily a transportation facility and ensures that designation as part of Redondo Beach Park will not interfere with its use as such.

<u>Alternatives</u>

The City Council may:

- 1. Enact the proposed Draft Ordinance as written.
- 2. Enact the proposed Draft Ordinance with modifications
- 3. Decline to enact the proposed Draft Ordinance.

Financial Impact

Staff believes the financial impact of the proposed Draft Ordinance is negligible.

Recommendation

Staff recommends that the City Council enact Draft Ordinance 23-003 as written.

DRAFT ORDINANCE NO. 23-003

AN ORDINANCE OF THE CITY OF DES MOINES, WASHINGTON relating to Parks and Recreation, designating the Redondo Boardwalk and adjacent tidelands under the control of the City as part of Redondo Beach Park and amending DMMC 19.12.010 and 19.12.020.

WHEREAS, the City Council has designated certain City owned or controlled real property as City parks for use by the public for recreation, listed in the Parks, Recreation, and Senior Services Master Plan, and

WHEREAS, one such City park is Redondo Beach Park located on the shore of Puget Sound in the Redondo neighborhood, and

WHEREAS, the Redondo Boardwalk lies along the west side of Redondo Beach Drive South, contiguous to Redondo Beach Park, and

WHEREAS, in addition to its use as a transportation facility for pedestrians, the Boardwalk is commonly used for such uses as recreational walking, viewing Puget Sound, dog walking, accessing Redondo Beach Park, jogging, and accessing the public tidelands adjacent to the Boardwalk, and

WHEREAS, as the Boardwalk and adjacent City-controlled tidelands are lands held open to the public that are utilized for recreational purposes contiguous and complementary to Redondo Beach Park, it makes sense to formally recognize these areas as part of Redondo Beach Park, and

WHEREAS, the City Council recognizes that the primary purpose of the Redondo Boardwalk is as a pedestrian transportation facility, integral to Redondo Beach Drive South Federal Aid Route 1007, and wishes to preserve the Boardwalk as such, and

WHEREAS, the provisions of this Ordinance are necessary and proper to promote public safety, health, and welfare; now therefore,

THE CITY COUNCIL OF THE CITY OF DES MOINES ORDAINS AS FOLLOWS:

Sec. 1. DMMC 19.12.010 and section 1 of Ordinance No. 1676 are each amended to read as follows:

Ordinance No. ____ Page 2 of 3

Park designation.

The areas listed in this chapter or identified as existing City recreation resources in the Parks, Recreation and Senior Services Master Plan as presently constituted or as may be subsequently amended are designated as City parks.

Sec. 2. DMMC 19.12.020 and section 2 of Ordinance No. 1676 are each amended to read as follows:

Redondo Park.

(1) Consistent with the City's harbor code (chapter 15.04 DMMC), Redondo Park shall be considered part of the marina as it constitutes City property adjacent to Puget Sound. Accordingly, the Harbormaster shall be responsible for management and enforcement actions to govern the use and enjoyment of Redondo Park. The Harbormaster's authority in Redondo Park shall include all powers granted under the City's harbor code as well as the power to enforce City park use regulations adopted under chapter 19.08 DMMC.

(2) Redondo Park shall include the Redondo Boardwalk and all tidelands adjacent to the Redondo Boardwalk owned or controlled by the City of Des Moines.

(3) City Park Use Regulations shall not apply on the Redondo Boardwalk to the extent they conflict with the use of the Boardwalk as a transportation facility or with any condition related to funds received for construction, repair, or maintenance of the Boardwalk. Maintenance of the Redondo Boardwalk shall be the responsibility of the Public Works Department.

Sec. 3. Severability - Construction.

(1) If a section, subsection, paragraph, sentence, clause, or phrase of this Ordinance is declared unconstitutional or invalid for any reason by any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

(2) If the provisions of this Ordinance are found to be inconsistent with other provisions of the Des Moines Municipal Code, this Ordinance is deemed to control.

Sec. 4. Effective date. This Ordinance shall take effect and be in full force thirty (30) days after its passage and approval in accordance with law.

Approval of the censure as written will remove Councilmember Harris from his appointed Council Committee positions until the end of this term, which is December 31, 2023.

DRAFT RESOLUTION NO. 23-006

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DES MOINES, WASHINGTON, CENSURING COUNCILMEMBER JC HARRIS FOR ACTING IN A MANNER UNBECOMING OF A COUNCILMEMBER.

WHEREAS, elected officials hold a public trust and are expected to adhere to a standard of behavior that does not violate or appear to violate that trust, and

WHEREAS, RCW 42.17A.001(2) states "that the people have the right to expect from their elected representatives at all levels of government the utmost of integrity, honesty and fairness in their dealings," and

WHEREAS, the City of Des Moines is committed to providing a safe workplace for its employees, guests, contractors, vendors and the public, and

WHEREAS, the City strictly prohibits threatened or actual workplace violence, this includes using obscene or abusive language or gestures in a threatening manner, and

WHEREAS, Councilmember JC Harris has been a member of the Des Moines City Council since January 1, 2020, and

WHEREAS, during his tenure, there have been numerous complaints from City staff regarding his demeanor and negative treatment of them, and

WHEREAS, as a result, City administration has been forced to put in place unprecedented protocols to ensure City staff is protected from offensive or uncomfortable interactions with Councilmember Harris, and

WHEREAS, despite the implementation of these protocols, Councilmember Harris has routinely disregarded them and continues to engage in behavior that places City staff in uncomfortable and inappropriate situations, and

WHEREAS, on December 9, 2022, a staff member sent an email informing Human Resources and her supervisor that the previous

night she had been confronted by Councilmember Harris and that she felt intimidated by this encounter, and

WHEREAS, this encounter occurred at night after a Council meeting while the staff member was alone in the small entryway to City Hall, and

WHEREAS, the staff member reported Councilmember Harris used profanity while angrily accusing her of failing to do something that was not even within her job responsibilities, and

WHEREAS, due to the seriousness of this complaint, as well as the repeat nature of this type of incident, the City retained an outside attorney to conduct a third party investigation, attached to this resolution as Attachments 1 and 2, and

WHEREAS, the result of the investigation confirmed the interaction occurred as reported, however, Councilmember Harris merely dismissed the confrontation as "unremarkable," and

WHEREAS, the verbal abuse of a staff member is inappropriate in any work setting, and characterizing this type of behavior as "unremarkable" provides further evidence of Councilmember Harris' use of bullying behavior towards City staff, and

WHEREAS, as an elected official, Councilmember Harris is not subject to discipline like a staff member would be if they engaged in this type of inappropriate behavior, and

WHEREAS, the City Council as a body does have the ability to declare that this type of treatment of City staff by a Councilmember is unacceptable and that it is unbecoming of the office that holds a position of power and trust, and

WHEREAS, Councilmember Harris has been advised multiple times by both City Administration and well as members of the City Council that his treatment of City staff is unacceptable, however these admonitions have failed to correct his behavior, and

WHEREAS, as a result, the City Council is now making a public statement of our disapproval of Councilmember Harris' actions and reaffirming our commitment to prevent hostile and intimidating treatment of staff members, and WHEREAS, a censure motion is made for the purpose of publicly denouncing inappropriate interactions or behavior, and

WHEREAS, the City Council approves this motion to state unequivocally that bullying, hostile or intimidating behavior has no place in the City of Des Moines; now therefore,

THE CITY COUNCIL OF THE CITY OF DES MOINES, WASHINGTON, RESOLVES AS FOLLOWS:

Sec. 1. Councilmember JC Harris is hereby censured for acting in a manner unbecoming of a Councilmember.

Sec. 2. The City Council approves of the removal of Councilmember JC Harris from all committee assignments for the remainder of his appointments.

Sec. 3. Notice of this Resolution of Censure shall be sent to all media outlets to whom the City of Des Moines sends official notices of public hearing.

Sec. 4. Notice of this Resolution of Censure shall be sent to all elected officials that represent the City of Des Moines.

Sec. 5. Notice of this Resolution of Censure shall be posted for a period of sixty days on the public notice bulletin board outside City Hall.

SUBJECT: SUMMARY OF FINDINGS-

AND JC HARRIS INTERACTION

Background

On November 29, 2022 Bonnie Wilkins, Chief Administrative Officer (CAO) sent an email to City of Des Moines councilmembers, inviting them to participate in the City's Senior Staff Leadership retreat, on December 12, 2022. She explained that each councilmember would be able to speak to staff directly about their perspective on various topics as it relates to their vision for the City of Des Moines.

They were provided fifteen (15) minute timeslots from which they could choose to schedule their appearance at the retreat. Councilmember JC Harris received the email invite and responded but she believed his responses were unclear and it was not apparent to Ms. Wilkins that he had selected a specific time or that he was planning on attending. On December 2, 2022, Ms. Wilkins emailed Mr. Harris specific timeslots in an effort to determine if one of those slots worked and to confirm his attendance. He did not respond. Ultimately, Mr. Harris did not attend the Senior Leadership Staff retreat.

After the council meeting on December 8, 2022, Mr. Harris met with City Clerk while she was alone in the foyer of the Council Chamber about not being confirmed for a timeslot for the Senior Staff retreat.

The following day, Ms. **Sector** sent an email to you (City Manager Matthias), Ms. Wilkins, Tim George, City Attorney and myself detailing her interaction with Mr. Harris. She stated that she felt like he had tried to intimidate her, that he was upset and angry and had used profanity when speaking to her. She also explained that she found his behavior to be "unprofessional and disrespectful." She then requested to have another staff member present in the future when she was locking up the facility due to her discomfort with his behavior.

After reviewing her complaint, the decision was made to retain a third party investigator to conduct a preliminary inquiry into her allegations regarding Mr. Harris' behavior. It is important to note, that councilmembers are not bound by City policy, however, Ms.

The City initiated our inquiry pursuant to <u>Section 2. General Policies and Practices, Discrimination</u> <u>and Harassment Complaint Procedure</u>. Summary of Finding(s)

Excerpt from final report:

- 1. and Harris generally agree on the substance of their December 8 interaction.
- 2. Despite their general agreement on the substance, and Harris did not perceive the interaction the same way.
- 3. Harris admitted he was frustrated that he had not been given a timeslot.
- 4. He admitted stating words to the effect of, "I never know if people are fucking with me or not."
- 5. Harris denied he was trying to intimidate **the second**. He said he was frustrated with not receiving a timeslot but was not angry with **the second** specifically.
- 6. He said he frequently uses profanity as a part of his normal speech, and it is not an indication of his mood or frustration level. He said if he learns someone is offended by profanity, he stops using it around them.
- 7. Harris said he is very sorry was hurt by the interaction; however, to him it was unremarkable.

<u>Policy Violation(s)</u> Section 2: General Policies and Procedures, F. Workplace Violence, 1. Workplace Violence Prohibition:

The City of Des Moines is committed to providing a safe workplace for its employees, guests, contractors, vendors and the public. Therefore, in an effort to help prevent or reduce the possibility of physical or emotional violence here in our workplace, the City of Des Moines has implemented this policy on workplace violence for our employees.

1. WORKPLACE VIOLENCE PROHIBITION

The City strictly prohibits threatened or actual workplace violence. This includes, but is not limited to, any of the following conduct associated in or around the workplace or otherwise related to employment:

f. Using obscene or abusive language or gestures in a threatening manner;

Section 8. A. Rules and Conduct, 1. Immediate Discharge:

IMMEDIATE DISCHARGE

There are certain kinds of actions that cannot be permitted to occur because of their impact on other employees and the City. Such offenses may result in discharge on the first occurrence. The following list contains examples of such offenses. This list of examples is not all-inclusive. Before a final decision is made regarding a discharge, the City will convene a pre-termination meeting as provided for in the section on discharge.

g. Threatening, intimidating, coercing or interfering with supervisors or other employees.

Summary of Findings_ and Harris, JC

Conclusion

As indicated in Ms. Haggard's final report, there is a general agreement about the "substance" of the conversation but a difference in perception of the event. Mr. Harris admits that he was "frustrated" though not specifically "angry" with Ms. **Event**. He also stated that he uses profanity as part of his regular communications and will only stop if told someone is offended. He also stated that he was "sorry if Ms. **Event**" was hurt" by the interaction but to him it was "unremarkable."

Mr. Harris is an elected official and Ms. **Sector** is the City Clerk for the City of Des Moines. A major function of the role of City Clerk is to provide administrative support to the Councilmembers as requested- guided by any relevant laws, guidelines, regulations and established City practices and procedures. Due to the nature of this relationship, e.g., work direction can be provided from the Council, there is a perceived perception of power that a councilmember has inherent authority within their position, particularly as it relates to the City Clerk's role. It is also important to mention that Ms. **Second** to the City Clerk role on July 1, 2022. She is still learning her role, the dynamics of Council and the various personalities of Councilmembers.

Mr. Harris' behavior, whether intended or not, created a situation where Ms. **Example** felt intimidated in the work environment. Additionally, his behavior led to a request by her to avoid future encounters with Mr. Harris unless others are present. Mr. Harris' behavior towards Ms. **Example** has unreasonably interfered with her work performance, where even the most mundane task of simply opening the door to let a Councilmember out after a council meeting, now needs two (2) staff members to perform to ensure Ms. **Example** feels comfortable in Mr. Harris' presence.

Though Mr. Harris stated that he was "sorry" if Ms. was offended; he also said that he felt the interaction was "unremarkable." This statement is concerning in that Mr. Harris was or should have been aware that Ms. was not involved with the scheduling of Councilmembers for the Senior Leadership Staff retreat. He also stated that while he was not "angry" with Ms. specifically, he admitted he was frustrated during the interaction. He also admitted to using profanity during their exchange.

Unremarkable is defined as *"not worth of note or attention...ordinary."* Mr. Harris admitted he was frustrated and used profanity in his interaction with Ms. **This interaction occurred-** away from Council Chambers or other staffⁱ in a small confined space, and was initiated by Mr. Harris regarding his frustration for not being given a timeslot at the retreat. For Mr. Harris to find this sort of interaction "unremarkable" is concerning because there are elements of this interaction, such as his using profanity to express frustration, that are considered unacceptable per City policy and current standards. In sum, what Mr. Harris described as unremarkable would warrant disciplinary action as unbecoming or gross misconduct if it were a City employee with authority over Ms.

Mr. Harris also stated that he uses profanity as part of his normal conversation but will stop if informed that someone finds it offensive. Mr. Harris' position that he understands that the use of profanity can be offensive for others in the workplace and is willing to not use it but puts the onus on someone to tell him its offensive is misguided. Rather, the adverse position of not using profanity in the workplace unless and until you know the other person is comfortable with it would be a more acceptable position, though the most prudent course of action is not to use profanity at all.

Summary of Findings_ and Harris, JC

It is unclear if Mr. Harris believes the use of profanity belongs in professional communication and interactions. Notable, however, is that Mr. Harris does not customarily use profanity at the dais during Council meetings so there appears to be some recognition by him that certain circumstances require a heighted awareness or sensitivity to adjusting communication styles based on the environment and whom you are talking to.

In addition, neither Ms. **Example** nor Mr. Harris indicated that they have a relationship where he could have comfortably assumed that his use of profanity, when couched in frustration and anger, could not be perceived as intimidating.

It would seem that Mr. Harris, as an elected official, should understand his responsibility to conduct himself in a professional and respectful manner towards City staff. Additionally it is concerning that, Mr. Harris did not take full responsibility for the interaction, his behavior and subsequent impact to Ms. without minimizing it later by recounting his perception of the event as "unremarkable" and only apologizing that Ms.

This suggests that Mr. Harris views his unprofessional interaction and communication with Ms. as the norm, which is unacceptable.

Next Steps

The City does not have the ability to enforce our personnel policies as it relates to the conduct of Councilmembers. However, this does not negate our responsibility to ensure that Ms. **Second** is able to perform her expected duties in the workplace free from this sort of behavior.

As a result, the following is recommended:

- Reinforce the appropriate communication protocol for Councilmembers to City staff.
- Reiterate the need for professional and respectful communication for Councilmembers to city staff.
- Ensure (as requested) that Ms. is not alone with Mr. Harris to the best of our ability.
- Empower Ms. with the ability to remove herself from any one on one interaction/communication with Councilmembers that involves anger, intimidation, profanity or is unprofessional and defer to Ms. Wilkins and/or the City Manager to address on her behalf.

ⁱ Ms. **Second** did not report remembering seeing anyone else around during her interaction with Mr. Harris. The video reveals that a person did enter the foyer while they are present, but the person does not approach the area of the room where they were interacting.

Dear Mr. Bolasina:

At your request, I conducted intake interviews with **Sectors**, Des Moines City Clerk, and JC Harris, a Des Moines City Councilmember. On December 9, 2022, **Sector** sent an email expressing concern about an interaction she had with Harris following the December 8 council meeting. I spoke with **Sector** on December 21, 2022, and Harris on January 3, 2023. This report constitutes a summary of the interviews and factual background.

On December 9, 2022, emailed City Manager Michael Matthias as follows:

When leaving the Council Chambers after the 12/08/2022 meeting, Councilmember stopped me in the Court lobby. He was very upset/angry and stated to me that he didn't appreciate that I didn't schedule him 15 minutes. I told him I didn't know what he was talking about. He said all he has ever asked for was 15 minutes with staff and that I didn't schedule him that. I then asked if he was talking about that Staff Retreat and he said yes. He said he asked to be scheduled a time slot before noon. I told him I wasn't in charge of his event and that "I" didn't schedule anyone for this event. I told him this event was planned by other staff and that I was invited to come. I told him I would let the staff who planned the event know he was upset about not being scheduled. He then said that he doesn't know who does what, that sometimes Bonnie does clerk stuff and then sometimes I do. He then went on to say he does know when people are "Fucking" with him or not. I then told him I would never do that!

I was confused as to why he chose to wait until I was alone to confront me. I felt like he was trying to intimidate me. I also don't appreciate the use of profanity when he was speaking at me. His lack of professionalism and respect was very disrespectful. Because I was very uncomfortable in this situation I am asking that I am not alone when locking up the facility after a Council meeting in the future. Mr. Mike Bolasina January 12, 2023 Page 2

Chief Administrative Officer Bonnie Wilkins had emailed the councilmembers on November 29 to invite them to speak, in fifteen-minute individual timeslots, at the staff retreat on December 12. Harris did not initially respond to Wilkins' invitation.

On December 2, Wilkins emailed Harris, stating, "Circling back to see if you are available/interested in attending the Staff Retreat on December 12th. If so, I do need to know as soon as possible....by next Monday. Time slots already taken are 10:30, 11:45 and Noon." Harris responded that he had not forgotten and asked if a list of suggested topics had been proposed.

Wilkins responded, "We're still working out details, but for logistics I need to know who is coming and what time. We may have to restructure depending on how many and at what times." Harris replied, "My preference(s) would be: start w 12:00 and work backwards." Harris told me he was trying to communicate that his schedule was flexible. He thought Wilkins would understand that she should schedule everyone else first then put him in an empty timeslot.

This was not clear to Wilkins, who responded, "12:00, 11:45, 11:15 and 10:30 are taken. 10:45, 11:00 and 11:30 are available." Harris did not reply, so Wilkins did not reserve him a timeslot. Five of the seven councilmembers reserved speaking times and three of those five showed up to the retreat.

and Harris generally agree on the substance of their December 8 interaction. Harris admitted he was frustrated that he had not been given a timeslot. He admitted telling that staff needed to communicate better in the future. He admitted stating words to the effect of, "I never know if people are fucking with me or not."

Despite their general agreement on the substance, **and** Harris did not perceive the interaction the same way. **Constitution** perceived Harris as angry and thought he was attempting to intimidate her. She said Harris could have spoken to her and Wilkins together in the council chambers rather than confronting her alone in the hallway. **Solution** said Harris's face was red, he spoke in a harsh tone of voice, and he was waving his hands around. She was offended by his use of profanity. **Solution** said she was so fixated on Harris's apparently hostile demeanor that she could not see anything else going on around her, including other people in the room.

Harris denied he was trying to intimidate **sector**. He said he was frustrated with not receiving a timeslot but was not angry with **sector** specifically. He said the conversation lasted only about a minute, during which time other people were nearby. He denied raising his voice or intentionally gesticulating with his hands. He said he uses profanity as a part of his normal speech, and it is not an indication of his mood or frustration level. He said if he learns

someone is offended by profanity, he stops using it around them. Harris said he is very sorry was hurt by the interaction; however, to him it was unremarkable.

Purpose and Recommendation

The purpose of this Agenda Item is for the City Council to consider Administration recommendations to reallocate \$565,000 of unspent American Rescue Plan Act funds.

Suggested Motion

FIRST MOTION: "I move to approve the recommended reallocation and expenditure of unspent American Rescue Plan Act funds."

SECOND MOTION: "I move to direct administration to prepare a budget amendment to incorporate the approved reallocation and expenditure of ARPA funds, and include such amendment in the next available budget amendment ordinance."

Background

In 2021, the City of Des Moines was awarded \$9,029,879 in funds from the American Rescue Plan Act (ARPA). In September of 2021, the City Council approved allocating these funds for 34 various projects. The City Council also approved creation of a fund in the City's general ledger to track expenditures of ARPA funds. It is a requirement of the ARPA grant that all funds must be obligated by December 31, 2024 and expended by December 31, 2026.

Discussion

At the end of 2022, through monitoring the balances of the ARPA projects, the City recognized that some projects had been completed, leaving a remaining balance, while others required fewer funds than anticipated. On January 12th, the following balances totaling \$565,548 were presented to the City Council as being available for reallocation:

Purpose and Recommendation

The purpose of this agenda item is to consider the presentations, discussion and citizen input received at the January 26, 2023 City Council Study Session regarding potential Marina Redevelopment options and to obtain direction from the City Council on next steps.

Motion

Recommended Motion: "I move to direct Administration to move forward with conducting feasibility studies for the public works projects for landside Marina Redevelopment."

Background

On January 26, 2023, the City Council held a study session solely devoted to potential Marina Redevelopment options and strategies. At that meeting staff and consultants made presentations, the Council asked questions and discussed the matter, and the public was given the opportunity to comment. Additional comments were received via email before the January 26 meeting as well as after.

Discussion

During the January 26, 2023 City Council study session, the Administration provided a recommended strategy for future Marina Redevelopment. This recommendation is to continue to pursue capital and infrastructure projects through public investment, and not to seek a private partner at this time.

However, in an effort to seek additional public input, the Council elected to delay any decisions until the February 2 regular Council meeting. The purpose of this item is to allow the Council to consider all options and make a recommendation for action.

<u>Alternatives</u>

- 1. Move forward with feasibility reviews of public infrastructure projects.
- 2. Move forward with feasibility reviews of public infrastructure projects while also seeking private partner for additional development.
- 3. Do nothing.

Financial Impact

Providing direction to pursue feasibility analysis will not result in significant expenditures outside of existing budgeted funds. Future council action would be required to approve design/construction contracts associated with Marina Redevelopment and project financing options. These potential projects are either in the existing capital improvement plan or will need to be added. City Council reviews, possibly amends, and approves the CIP annually as part of the budget process.
