MEETING:

- 1. Unanimous approval of the 09.12.2024 minutes.
- 2. City Engineer Tommy Owen introduced Khai Le, Principal Engineer for his presentation of this item. Mr. Le provided a memo and a PowerPoint South 223rd Green Street Study Report April 2024. He stated the missing pedestrian connection from downtown to the Marina has been on the City's radar for quite some time. This project received a Commerce Grant in 2022 for preliminary planning and design, environmental permit identification and public outreach. Staff and public reviewed different design themes with the Waterland Theme being chosen through a public survey. This project includes a pedestrian safety focus with proposed stormwater quality features. The committee discussed:
 - Traffic calming measures
 - Cross section of the Right-of-Way
 - Potential funding sources
 - Landscaping

The project is currently paused while staff research funding opportunities. It is Project #15 on the 2031-2034 TIP.

3. CE Owen provided a list of Transportation staff managed projects under these headings: Current Construction; Planning, Engineering, ROW Acquisition; Planned Construction; Large Project Support; Projects Targeted for Grant Funding. Principal Engineer Le updated the committee on the 24th Ave S Sidewalk Improvements Project, which continues to be a challenge after additional utility conflicts were discovered. SCI work has been suspended until mid-February or early March of 2025. Staff are working to make sure the roadway is stabilized along with ensuring pedestrian safety. Negotiations have started with PSE to recoup costs of construction delays. Additional details were discussed regarding the Redondo Restroom Replacement, the Marina Steps, the Redondo Fishing Pier, Sound Transit Light Rail and WSDOT SR509 support. CE Owen reviewed a memo of 2024 projects completed and underway in the Redondo neighborhood.
