Puget Sound Gateway Program




The **Puget Sound Gateway Program** is composed of two projects: the SR 167 Completion Project in Pierce County, and the SR 509 Completion Project in King County.

- Essential connections to the ports of Tacoma and Seattle
- Ensure people and goods move more reliably through the Puget Sound region
- Enhance the state's economic competitiveness by connecting the state's largest ports to key distribution centers

Delivering the projects under one program allows WSDOT to realize efficiencies in planning, environmental review, design, and construction.

 Open to traffic by 2029




- 509 corridor site prep work underway in SeaTac

216th Bridge Coordination

- WSDOT coordinated with the City of SeaTac and the City of Des Moines to develop the RFP Concept.
- The RFP addressed both the current need to replace the bridge and future potential for the buildout of S. 216th Street.
- The RFP concept staging was coordinated, such that the partial closure of the bridge provided continuous pedestrian access and westbound vehicular access (S.216th MOU) as part of construction staging.




S 194th Street - Closure Stage 2

 S 194th Street between 11th Place South and Des Moines Memorial Drive will be closed per WSDOT EIS and Access Hearing in coordination with local agencies.



History of collaborative planning w/ Des Moines

Barnes Creek Mitigation Site Stage 2

10-year Monitoring and Maintenance Plan (MMP):

- WSDOT is obligated to monitor and maintain the Barnes Creek Mitigation Site
- <u>Plant Establishment</u>: Will begin on the 2nd year for another 9 years. WSDOT will be responsible for up to 10 years of invasive removal and plant establishment in all planted areas.
- Typical elements of maintenance plan: Noxious weed removal, litter removal, cleanup

Schedule:

• WSDOT plans to implement proposed activities at the Barnes Creek mitigation site concurrent with the SR 509 Stage 2 Project construction. Construction is expected to start in 2024 and last approximately 1 to 2 years.

Transfer of Property:

• Once the site has met all the performance standards outlined in the MMP, the site will begin the close out process. At the conclusion of this 10-year plan, WSDOT will seek to transfer property to the City of Des Moines.




Barnes Creek Mitigation Site Stage 2
