Economic Development: Why Are Downtowns Important?

The economic vitality of our community and the City's financial strength are important issues the City Council will be addressing over the next several months. For the next several issues of *City Currents*, we will be presenting articles on economic development and City finances. This first article focuses on downtowns and why a healthy downtown is important to a city.

Although malls and discount centers are convenient, these places can never take the place of a healthy, vibrant downtown. Downtowns are more than just opping places; they play an important ic role in our city. They help define a community's image. Downtowns are often the central business center of a city,

employing hundreds of people. Downtowns usually have the highest concentration of small, independent businesses. Your neighbor, your child's soccer coach or other citizens just like you, often own these independent businesses that help keep our hard-earned dollars local.

Downtowns are a reflection of how a community views itself. When an industry looks at a city as a possible new home, they examine many aspects including the quality of life. Included in this assessment is the downtown—is it alive and viable or does it represent disinterest and failure?

As you can see, a strong downtown provides so many positive benefits to a city. Breathing new life into Des Moines' downtown will be a major component to an overall economic development strategy, allowing us to maintain and enhance our quality of life.

City Council Approves 2004 Budget

The City's 2004 annual operating and capital budget was adopted by the City Council on December 22, 2003. The 2004 xpenditure budget for all City funds totals \$50,298,265. The able below highlights the 2004 and 2003 operating and capital budget expenditures, revenue estimates, and the percentage change from 2003's adopted budget.


The 2004 increase in operating expenditures primarily results from the following policy decisions recommended by the City Manager and approved by the City Council:


- Restore the equipment replacement and computer equipment replacement assessments deferred in 2003.
- Fund various capital equipment and vehicle replacements deferred in 2003.
- · Fund various new equipment and software upgrades.
- Fund needed facility repairs.
- Fund Airport Defense.
- Fund limited-term positions in the Building Division as a result of increased construction activity.
- Fund consultant studies to update emergency management plan, to assist with economic development strategy, and to provide analysis of Marina moorage and electric rates.
- Fund increase in general fund transfer for capital improvements and video equipment.

The general and street funds comprise the general governmental operating budgets for the City. The general government operations include legislative, executive, judicial, financial, legal, law enforcement, public works, community development, and parks, recreation and senior services. Resources supporting hese expenditures are primarily derived from general purpose revenues such as: property, sales, utility, leasehold, and gambling taxes; licenses and permits; federal, state, and local shared revenues and assistance; charges for services; fines and forfeits; and culture and recreation fees. The 2004 budget was developed recognizing that continued new construction activity would generate one-time sales taxes and building permit and plan review revenues sufficient to fund basic service levels plus the policy

decisions discussed above.

The following graphs provide the percentage breakdown by revenue type and expenditure classifications for the 2004 general governmental operating budget.

Street and Vegetation Maintenance

Vegetation control and road shoulder mowing in 2004 will be done on a limited basis along main arterials and state routes. Most residential vegetation control is the responsibility of adjacent property owners. Sight distance impairments at intersections will be corrected when found, as will low overhanging tree limbs and other vegetation that may encroach on public rights-of-way. The Street Maintenance crew of five members is responsible for maintaining approximately 100 miles of roadway, which averages about 20 miles per employee.

Curbside Spring Clean Collection Event: April 26-30

The City of Des Moines and SeaTac Disposal are providing another Spring Clean Collection Event.

SeaTac Disposal will collect garbage, recyclable materials, and yard waste placed at the curb on your regular garbage collection day between Monday, April 26 and Friday, April 30.

This FREE collection event is available only to single family residences, duplexes, triplexes, and fourplexes within the City of Des Moines. Each collection vehicle (garbage, yard waste, recyclables and bulky items) will drive by only once. You do not need to be a customer of SeaTac Disposal to participate. If you have any questions, please contact SeaTac Disposal at 253-682-9735.

PLEASE FOLLOW THESE INSTRUCTIONS:

- Materials must be sorted into the appropriate pile. Separate piles should be made for garbage, recyclables and yard
- Materials must be placed in containers (i.e. paper bags, cardboard boxes, cans, etc.) and clearly labeled.
- All materials must be placed at curbside no later than 7 a.m. on the day of service.
- Tires and hot tubs will not be collected.
- Yard waste must be bundled with natural fiber twine or placed in a labeled container, can, cardboard box, or biodegradable bag (plastic bags will not be picked up).
- Pick up of bulky items and appliances must be prepaid. Purchase your tag by Friday, April 23, at the Des Moines Community Development Department, 21630 11th Ave. South, Suite D.
- Absolutely no hazardous waste items or their containers will



be collected. Hazardous waste includes paints, solvents, pesticides, motor oil, antifreeze, and batteries. Save these items for drop off at the Household Hazardous Wastemobile. For a schedule call 206-296-4692, 1-800-RECYCLE or log onto http://www.govlink.org/hazwaste/.

ITEMS TO BE COLLECTED

Appliances and Bulky Items

Set tagged appliances or bulky items at the curb by 7 a.m. Monday April 26 (for collection on April 26 or 27). Tags for refrigerators, freezers and air conditioners cost \$45 because they contain harmful gases that can damage the ozone if not disposed of properly. For all other appliances, tags cost \$30. All appliances will be recycled.

Tags for bulky items weighing more than 60 lbs. cost \$30. For bulky items weighing less than 60 lbs., tags cost \$20. All tags may be purchased at the Des Moines Community Development Department located at 21630 11th Ave. South, Suite D. between 8:00 a.m. and 4:30 p.m. Please phone 206-870-7576 with any questions.

Garbage

Garbage is waste material and does not include tires, recyclables, yard waste or hazardous wastes (i.e. paints, pest killers, petroleum products, solvents, etc.). Garbage items and full containers must not weigh more than 60 lbs.

Recyclable Materials

Recyclable materials consist of newspapers, magazines and junk mail, cardboard, aluminum, tin cans, plastic bottles with a 1 or 2 stamped on the bottom and glass beverage/food containers. Glass (green, brown, and clear) bottles and jars must be placed in a separate container from the other recyclable materials.

Yard Waste

Yard waste includes grass clippings, branches/prunings (le than 3 ft. long and 3 in. in diameter) or leaves. Rocks, dirt and sod are not acceptable. Yard waste must be bound with natural fibers into a bundle no larger than 3'x3' or placed in biodegradable containers (i.e. cardboard boxes or paper bags) or yard waste containers. Containers and bundles must not weigh more than 60 lbs. Yard waste in plastic bags will not be collected.

Household Hazardous Waste Collection and Recycling Event Saturday, April 24, 9 a.m. to 3 p.m. at the Des Moines Marina

- · Cardboard: Please flatten. No wax-coated cardboard.
- Tires: Bias ply, steel belted, and studded tires accepted. Limit 6 tires per load (18 inches and below) free of charge. No oversized tires accepted (heavy truck or back hoe tires). No tires on rims.
- Reusable Household Goods: Clothing and miscellaneous household items in good condition. Mattresses, furniture and items in need of repair will not be accepted.
- · Residential Porcelain Toilets and Sinks: Please remove toilet seats, hardware and base wax rings. \$5 fee (cash only).
- · Lead Acid Batteries: Car, truck, marine, and motorcycle batteries accepted.
- Household Batteries: AAAA, AAA, AA, AA B, C, and D cell batteries only.
- · Motor Oil, Filters and Anti-freeze: Motor

- oil, oil filters, antifreeze, brake fluid, transmission fluid, 2-cycle oil, steering fluid, crankcase oil, kerosene, and home heating fuel. Do not mix with antifreeze, solvents, gasoline, or other substances.
- Appliances and Scrap Metal: Auto parts, lawn chairs, lawn mowers, stoves, barbecues, iron, steel, aluminum, brass, copper and other ferrous and nonferrous metals. \$5 fee (cash only) for each water heater that still has insulation coating. Metals that are insulated, rubber or oil coated, previously or currently contain chemicals, paint, or hazardous materials will not be accepted. Light fixture ballasts and sealed drums will not be accepted.
- · Refrigerators, Freezers and Air Conditioners: \$25 fee (cash only) for each refrigerator or freezer. \$25 fee (cash only) for each household air conditioner.

- · Concrete, Rock, Asphalt and Brick: Residential material only. No wood, plastic or metal attached. Please lay material on top of a tarp for ease of removal.
- Electronic Equipment: Computer hard drives, printers, mouse, keyboards, fax machines, cellular phones, and scanners. Computer monitors will be collected for \$10 each (cash only). Television sets will be collected for \$15 each (cash only). No wood encased, wood console, or big-screen televisions.

Pacific Highway South Improvement Project Update

Please excuse the dust and minor deavs associated with the reconstruction of acific Highway South. Construction began in August 2003, and should be complete by February 2005. The City of SeaTac plans to extend International Boulevard improvements southward to S. 216th this summer. Construction activities on Pacific Highway So. for the City of Kent are also underway, which begins at Kent-Des Moines Road and extends south.

Progress to Date:

- · Utility trenching, underground vault placement, and conduit runs for the undergrounding of overhead utilities have been completed.
- Modular Block retaining wall construction is nearing completion.
- · A new underground stormwater conveyance system is half-completed through the corridor.
- The underground portion of the new project street lighting system, and the new intersection and pedestrian signal systems are nearly complete.
- The concrete curb and driveways are early complete on the west side of Patific Highway South. The remaining segments will be completed after the utility poles are removed.

Estimated Project Timeline: April through May 2004

The contractor has the traffic lanes shifted to the east and is currently focusing on roadway improvements on the west side of the highway. Roadway improvements include underground utilities, curb and gutter, sidewalk, and widened pavement. Following construction of the west curb, the traffic lanes will be shifted to the west for this same scope of work on the east side of the highway. The traffic shift will probably happen in late April. During this time, the contractor will also work on improving the profiles of the streets approaching Pacific Highway on the west side to provide better visibility at the intersections with the highway.

June through October 2004

Work will continue on completing underground utility connections and subgrade preparation including roadway embankment work on the side streets on the east side of the highway. Completion of subgrade asphalt work, concrete curb, gutter, and sidewalk will be a priority during the summer months. New signal poles, controllers, illumination poles, and electrical tie-ins will also be completed during this time period.

Stormwater ponds will be constructed at Kent-Des Moines Road, South 222nd Street, and South 220th Street.

The construction of the landscaped median area will begin in July. The construction of the final lift of asphalt pavement is planned for early October.

Nov. 2004 through February 2005

Final work elements include irrigation and landscaping at the pond sites and along the corridor as well as installation of gateway signage and architectural fea-

Upcoming Impacts

During the next few months, owners and tenants of properties along Pacific Highway South can expect to see concrete curb installation. When the project is complete, all properties will be served by new concrete driveways. Ceccanti will be meeting with property owners/ tenants to discuss construction of their driveways. This is one of the most complex scheduling tasks on the project. Generally, properties with more than one driveway will have one driveway maintained while the other is constructed; owners with only one available access will have their driveways constructed in two segments. Time will be required for the new concrete driveways to properly cure. Some properties may prefer to have their driveway constructed in one pour to reduce the total length of time in which Ceccanti is working in their vicinity.

Utilities are now available from the new underground system for properties on the highway between Kent-Des Moines Road and South 224th Street. The remaining underground system work between South 224th Street and South 216th Street will be complete by the end of April. All property owners along the highway who are still connected to any overhead utilities must make arrangements for, and complete their connection to the new underground systems. Owners must have this work completed within 90 days of receiving their notification.

Work Begins on Marina Renovations

In June of 2001, the Des Moines City Council adopted the Comprehensive Master Plan for the Des Moines Marina. The centerpiece of the Master Plan is a project that will expand the existing guest moorage area, replace the timber bulkhead and renovate the north end of the Marina.

In January of 2004 the City Council approved a contract with Moffatt & Nichol Engineers for the design, engineering and permitting phase of the guest moorage expansion and the renovations planned for the north end of the Marina. The engineers began when drilling crews arrived at the Marina to do the borings to determine the sub-surface conditions. Moffatt & Nichol began investigating the existing condition of the bulkhead, parking lots, and the floating docks.

Moffatt & Nichol and their sub-consultants, Makers Architects and Urban Design, and Worthy and Associates Landscape Architects, met with City staff and the City Council's Municipal Facilities Committee (Mayor Bob Sheckler, Mayor Pro-Tem Scott Thomasson and Council Member Gary Petersen) to discuss the options for land-scaping, light fixtures, sidewalks, railings and other amenities planned as part of the renovations. The Municipal Facilities Committee members expressed a preference for a patterned concrete surface for the sidewalks, with some colored concrete in selected areas. The Committee also preferred a basic railing with a sloped wooden top rail similar to the existing railing. The Committee recommended using furniture, light fixtures and landscaping that will reflect the design theme used for the Pacific Highway project. Their recommendations included orienting trees and shrubs to maximize views and keeping the plantings simple and easy to maintain.

Moffatt & Nichol is planning to deliver a series of technical memos to the City, detailing the options for reconstruction of the bulkhead, reconfiguration of the floats, and design options for the entrance of the Marina. The City Council is expected to discuss these options in late April.

King County Housing Repair Program

King County provides 0% interehousing repair loans to low and modelate-income homeowners. The program



also helps landlords make rental units accessible for handicapped, income-eligible tenants. These programs are funded by the City of Des Moines and King

County and are administered by King County staff.

These loans can fund a wide variety of home repairs. Highest priority is given to health and safety repairs such as roof, plumbing, electrical and heat systems and septic systems, but other repairs may also qualify. Eligibility is determined by income. A family of four can earn up to \$56,000, which is 80% of King County median income. Income is adjusted by family size.

Our Comprehensive Plan sets general policy regarding issues such as land use, transportation, housing, and protection of the environment.

The update process will culminate in adoption by the City Council, but public hearings will be held before any final decisions are made.

- Carry only the credit cards that you use regularly.
- Keep valuable jewelry in a safe deposit box.
- When you see something suspicious, call 9-1-1. Police would rather respond to a "suspicious" call and prevent a burglary than take a victim report.
