Upgrade of Council Chambers Audio-Visual System Underway

Studies are underway for renovation of the audio/visual system in the Council Chambers. The project includes replacing the broadcast equipment for the City's public education and government cable TV channel (Comcast Channel 21), and upgrading lighting and acoustics in the Council Chambers to give video recordings of the Council meetings a clean and professional look. For years, the City has received complaints about the poor quality of the sound and visual images of Council meeting recordings. "Most of the existing equipment is 20 years old," explains City Manager Tony Piasecki. "Citizens

who take the time to watch a Council meeting from home can't hear what was being said."

Funds for this project come from Des Moines' cable TV subscribers. A small fee will be added to cable TV bills to generate the money needed. Video recordings of Council meetings are currently available on Channel 21, the City of Des Moines' website (www.desmoineswa.gov), from the City Clerk's office, and the Des Moines Library. Once the upgrade is complete, the quality of these recordings will be greatly enhanced. Also, they will be available on DVD as well as video tape.

Improvements at the Historic Field House

Recent improvements at the Field House will alleviate drainage problems and improve accessibility to the building. New drains have been installed around the exterior of the building to intercept surface and ground waters that have plagued the building for years. The basement is expected to remain dry throughout the winter—a big improvement for the 64-year-old building. The old steps and pathways did not meet today's requirements for accessibility. The new sidewalks are safer and more attractive.

The Field House is a King County Landmark and all renovations must retain the building's historic character. For example, the old river-rock gutters around the building foundation are being removed, restored, and re-installed. This project achieves two important items on the long list of improvements needed at the Field House.

Redondo Boat Launch Improvements

Work is progressing on this important construction project. The boat launch and the parking lot will be closed for the remainder of this boating season. The facility will reopen by the end of the year for general parking and die-hard boaters. In the spring, the boarding floats and the floating breakwater will be re-installed for the 2004 boating season. Meanwhile, launching service is available at the Des Moines Marina.

Pacific Highway South Improvements

The City of Des Moines and its contractor, Ceccanti, Inc. of Spanaway, broke ground on the Pacific Highway South Roadway Improvement Project on August 18th. The construction schedule calls for project completion in February 2005. The City of Des Moines segment of Pacific Highway, which begins at S. 216th Street to Kent-Des Moines Road, will add a new and exciting doorway to our City. The cities of SeaTac and Kent are planning improvements to Pacific Highway So. to the north and south of Des Moines' improvements.

As with any construction project, there will be some inconveniences. The benefits, however, will outweigh the inconvenience.

Given the mix of commercial, residential, schools, transit, and recreational uses within the Downtown area, and given the existing sidewalk system, it has been the City's intent to en-

courage pedestrian travel. However, some concern has been voiced that Marine View Drive South presents undue crossing difficulty for pedestrians at its unsignalized downtown intersections. Considering that Downtown Marine View Drive South carries a large traffic volume of approximately 20,000 vehicles per day, the system works reasonably well for pedestrians. In tests done by the City Engineering Division, pedestrian delay is generally much less than at a signalized intersection, and there are very few pedestrian related accidents on record. However, as with most every roadway, there is some room for improvement where motorist-pedestrian vielding behavior is concerned.

In an attempt to improve the pedestrian crossing situation, an experimental crosswalk treatment is being tried on Marine View Drive South at South 219th Street. The treatment consists of small signs reminding pedestrians to give a clear indication of intent to cross the street, and supplementary sidewalk stencils showing pedestrians where to stand to be most visible to affic. Observation on Marine View Drive consistently shows that the further a pedestrian stands from the roadway, the more difficult their crossing attempt becomes. This is most likely

because drivers do not see the pedestrian until it is too late to comfortably stop, or they are uncertain whether the pedestrian is attempting to cross the road at all.

According to Washington State law, motorists are not required to stop for a pedestrian unless they have clearly begun to cross the road. While the Engineering Department would not advise crossing in front of a moving car, it does recommend standing near the roadside and clearly indicating a desire to cross. RCW 46.61.235 (2) reads "No pedestrian or bicycle shall suddenly leave a curb or other place of safety and walk, run, or otherwise move into the path of a vehicle which is so close that it is impossible for a driver to stop." While motorists are not perfect, it is important to remember that a driver cannot be expected to stop unless they can

see the pedestrian and recognize that they are attempting to cross the street. The Police Department will continue to conduct crosswalk "decoy emphasis" and ticket those motorists who fail to yield to pedestrians.

The Engineering Department will conduct further observational studies to determine the effectiveness of the experimental treatment and would welcome comments or suggestions. To comment on the experimental treatment contact Mike Holmes at 206-870-6592.









Grandview Park Off Leash Area Opens October 4

At last, dogs and their owners have their own designated off leash area to serve south King County residents. Through the cooperative efforts of the City of Des Moines, King County, Serve Our Dog Area (SODA) and the cities of SeaTac, Auburn, Burien, Federal Way, Kent, Renton and Tukwila, the first regional south King County off leash area will be dedicated and opened for public use on Saturday, October 4, 2003 at 10:00 a.m.

The new off leash area is located at Grandview Park, a 37-acre facility located in the City of SeaTac at South 228th Street and Military Road South. The park offers beautiful views of Mount Rainier and the Green River valley with easy access from I-5, Pacific Highway South and State Route 516. Amenities at the off leash area include fencing, trails, open areas, benches, kiosk, sani-cans and waste receptacles. The off leash area is open from dawn to dusk daily.

The park was refurbished for use as an off leash facility through the joint efforts of the south King County cities, SODA members and volunteer groups from Boeing Company, Key Bank, LDS Church Ward #1 and local Boy Scout Troops. The off leash area will be operated and maintained by SODA volunteers. Each partnering city and King County provided development funds, as well as labor and equipment to build the park.

Tobacco Prevention Project

The use and exposure to tobacco products is a major health concern throughout the world, nationally, and within our own communities. Through



successful tobacco cessation/diversion programs, we as a community have educated many people of the serious health consequences

of the use of these tobacco products. Although the health consequences are known, about three million people die each year due to tobacco related diseased. Tobacco is still the single most preventable cause of death and disease in our society.

In order to further encourage the nonuse of these harmful tobacco products, enforcement agencies must enforce our tobacco laws, especially dealing with our youth. According to Seattle-King County Department of Public Health, 80% of all smokers today started smoking prior to being 18 years old.

For the past three years, the Des Moines Police Department has obtained grant funds from the Seattle-King County Department of Public Health to implement and operate its Tobacco Prevention Project. The purpose of this Tobacco Prevention Project is to promote awareness of the youth possession law and to enforce the tobacco laws within the city. This Tobacco Prevention Project first started when Des Moines received grant funding in January 2001; additional funding was obtained the following two years. Recently the Des Moines Police Department was awarded another grant from the Seattle-King County Department of Public Health in the amount of \$15,000 to continue its efforts to promote awareness and enforce the tobacco laws within the City of Des Moines. The Des Moines Police Department's Tobacco Prevention Project will continue in September 2003 and is scheduled to end in June 2004.

The Des Moines Police Department's

Tobacco Prevention Project has obtained outstanding results and the Seattle-King County Department of Public Health considers it a "Model Program" for other police agencies. Representatives of the Police Department have presented this program to numerous other law enforcement agencies, as well as the Washington State Tobacco Prevention Bidders Conference in April 2003. Back to School Checklist for Parents

Summer's over and school is back in session. If you haven't already discussed these safety tips with your children,



please take a few minutes to review them now. Be sure your child knows his or her full name, home phone number and address. It is also a good idea to make sure your child knows your work

number and the number of a trusted adult, plus how to use 9-1-1 for emergencies.

Plan a route to school or the bus stop with your child. Emphasize the importance of walking with a brother, sister, friend or neighbor.

When carpooling, remember to deliver or pick children up as close to the school as possible, and never leave until the child has entered the building.

Teach your child not to talk to strangers or accept rides or gifts from strangers.

Be A Safe Pedestrian and Driver

Every year millions of children walk to school or to a bus stop. School age children are especially vulnerable to pedestrian crashes, which result in tens of thousands of injuries and hundreds of deaths each year.

Parents and motorists have a responsibility to help ensure the safety of child pedestrians. It is important to keep in mind that children are not small adults. Until they are at least 10 or 11 years old, children don't have the skills to handle traffic. Because they are short, it is difficult for children to see motorists or for motorists to see them. Because their peripheral vision is approximately onethird narrower than an adult's, children can't see a motorist approaching from the right or left as soon as an adult can. Children also have difficulty judging a car's speed and distance and they often think that if they can see the driver, the driver can see them.

Parents or other responsible caregivers must supervise children at all times. They must teach children how to cross the street safely, and they must always set a good example when crossing the street with children.

Drivers should observe speed limits at all times, but especially around children. When driving in school zones, near playgrounds, or in neighborhoods where children might be playing, motorists should always expect a child to dart out into the roadway. When turning left at a green light or making a right turn on red, drivers need to look for pedestrians as well as cars.

Keep Your Pets Safe on Halloween

Halloween is coming and although it's a fun time for children and adults alike, it can be VERY SCARY for our pets! You may get a kick out of your scary costumes, but unusual sights, sounds and movements can create anxiety in all kinds of pets, especially dogs. Also, trick-or-treaters ringing the doorbell over and over can cause severe frustration; your dog could uncharacteristically bite someone or run into the street. To avoid a bad situation during Halloween, keep all your pets safely confined in your home.

REUSABLE HOUSEHOLD GOODS: Clothing and miscellaneous household items in good condition. Mattresses, furniture and items in need of repair will not be accepted.

RESIDENTIAL PORCELAIN TOILETS AND SINKS: Please remove toilet seats, hardware, and base wax rings. \$5 charge (cash only).

LEAD ACID BATTERIES: Car, truck, marine and motorcycle batteries accepted. **HOUSEHOLD BATTERIES:** AAAA, AAA, AA, B, C and D cell batteries only.



PROPANE TANKS: Residential tanks only. \$5 charge (cash only).

BULKY YARD WASTE & SCRAP WOOD: Includes tree branches (minimum 6 inch diameter), clean wood, plywood, pallets, and other untreated and unpainted wood. No leaves, grass, small branches, sod or brush. Please lay material on top of a tarp for ease of removal.
