Grand Parade Moves to Sunday

ig news for all Waterland fans. This year's Waterland Grand Parade has been moved to Sunday instead of its traditional Saturday time to avoid a conflict with Seafair's Torchlight Parade.

The annual Waterland Festival kicks off with a fireworks display at the marina at 10 p.m. Wednesday, July 26, and continues through the weekend with the Grand Parade on Sunday, July 30, starting at 2 p.m.

The Grand Parade actually is four parades in one. First is the Junior Parade, followed by Pets on Parade and then Parade for Hunger where volunteers collect nonperishable food items along the parade route for donation to the local food bank.

The Grand Parade is the big event of the day. Traveling north on Marine View Drive, the parade features clowns, floats, antique cars, drill teams and marching bands from all over the state. This year's parade Grand Marshal is Carl Jensen, recently named Highline's Citizen of the Century for his many contributions to the community in the area of education.

Des Moines residents are invited to join the other fun events and activities throughout the festival. Most of the activities and displays take place at the marina, including the carnival, live entertainment, food booths, and arts and crafts displays.

This year festival attendees can park in the South Marina Parking Lot for a nominal \$5 fee. Other options for parking include:

· Street parking in downtown Des Moines.

 Parking at Highline Community College north parking lot and riding a shuttle bus to the marina. The shuttle will run every 30 minutes. Hours: 3-11 p.m. Thurs., Fri.; noon-11 p.m. Sat.; 1-7 p.m. Sun. Cost: Adults \$1; Children under age 12, 50 cents; round trip.

New Street Light Utility Established

s reported in the April edition of "City Currents", the City of Des has established a Street Light Utility to provide for the operation, maintenance, and installation of street lights and traffic signals in the City. Every resident and business in town benefits from the enhanced safety provided by lights and signals. The cost of operating and maintaining the City's street light and traffic signal system is over \$260,000 annually. Funds from the newly formed utility will pay for these costs plus provide resources for installation of new street lights in areas currently underserved and additional traffic signals at locations where they are warranted.

Street Light Utility service charges will be calculated by using either a) the City's pre-existing minimum parking space requirements for residential properties, commercial businesses and other uses, or b) the guidelines in the Institute of Transportation Engineers manual. Minimum parking spaces are used because this is a fair and reasonably accurate way to estimate the number of traffic trips and/or vehicles that will visit a particular type of property and thus the amount of Street Light Utility service the use at the property receives. The monthly fee will be \$1.25 per minimum required parking space or \$15 annually per space. As an example, single family homes are required to have at least two parking spaces and will be charged \$2.50 per month or \$30 per year.

A brochure providing detailed information regarding the Street Light Utility was mailed in late June and will be included in the first billing. The first bills will be sent in July. Payment will be due within 30 days of the billing date.

Pacific Ridge Redevelopment Study Nearly Complete

draft land use plan for the area along Pacific Highway South was published on May 24. As announced in several of the past editions of *City Currents*, the City Council has been discussing how to revitalize the area bounded by South 212th Street (alignment) to the north, Kent-Des Moines Road to the south, Interstate 5 to the east, and 24th Avenue South to the west.

This area of Des Moines is known as Pacific Ridge, and the redevelopment study contains a new vision for Pacific Ridge, an assessment of environmental impacts, and new zoning regulations. The title of the study is the Pacific Ridge Neighborhood Improvement Plan.

Public meetings have been in progress for months on the various components of the study. The Plan allows taller buildings built closer to the street in order to create a more pedestrian-friendly community.

All new construction will include crime prevention design features to help discourage crime. Because the Pacific Ridge Neighborhood Improvement Plan takes a comprehensive look at redevelopment, the time needed for the City to review individual development proposals will be reduced.

Watch for renovation to begin soon on the Safeway store at South 216th Street and Pacific Highway South. This construction will enlarge and modernize the existing grocery store, and make the parking lot more attractive and safer. City staff is available to meet with property owners considering developing or redeveloping their land.

The City of Des Moines encourages new construction in Pacific Ridge as a way to improve living, working, and business conditions along and near Pacific Highway South.


Des Moines Receives Temporary State Assistance

n April 27, 2000, the State Legislature approved a partial and temporary solution to the funding gap created by Initiative 695 for local governments. Over the next two years, the City of Des Moines will receive \$2,163,000. One-third (\$721,000) of the City's total assistance was received in May 2000. The balance (\$1,442,000) will be distributed in the calendar year 2001. The City of Des Moines lost \$4,253,000 in State Shared Revenues in 2000 and 2001 as a result of I-695. Even with the recently approved assistance, the net loss to Des Moines in state revenues for the two years totals \$2,090,000.


In an effort to maintain the City's existing level of critical services, in late 1999 the City Council reduced annual expenditures as well as authorized increases to marina moorage rates, building permit fees, property taxes, business license fees, utility taxes and created a Street Light Utility District. Combining these Council items with the decreased revenue from the State, the City will realize a net reduction of approximately \$200,000 from I-695 for 2000 and 2001 combined.

With the new state temporary assistance, the City is able to avoid the additional \$1 million in budget reductions that would have gone into effect July 1. This allows the City to maintain its current levels of police, senior services, street maintenance, parks, and other basic services at least through 2001. If no permanent replacement funding is provided by the state next year, significant service reductions will be required in 2002.

FALL RECYCLING EVENT

Get Ready, Set, Recycle!

s you are puttering around your home this summer, remember that the City of Des Moines is again sponsoring a fall special collection and recycling event to further reduce the amount of hazardous materials within the City. The one-day event will be held on a Saturday in October (the exact date to be determined) and will be located at the south end of the Des Moines Marina parking lot near Anthony's Home Port.

The intention of this collection event is to provide our community the opportunity to dispose of hard to recycle materials such as: old tires, lead acid car and boat batteries, motor oil and filters and other petroleum products, antifreeze, concrete, rocks, appliances (for a small fee) and other types of scrap metal, porcelain toilets/sinks (for a small fee), cardboard, and reusable or recyclable household goods.

Household hazardous waste like paint, solvents, pesticides, glues and the like will **not** be collected at this event. Those types of materials should be taken to the nearest Wastemobile.





City Studies Assumption of Water Districts

The citizens of Des Moines receive water services from three special purpose districts serving the South King County area: Water District No. 54, the Highline Water District, and the Lakehaven Utility District. The City of Des Moines does not provide this basic municipal service. In December 1999, the City Council directed City staff to study the feasibility, benefits, and costs of the City providing water services rather than these districts. In early June, staff presented the preliminary report to the City Council.


The report concluded that there would be significant benefits to the citizens of Des Moines if water services were consolidated and provided directly by the City. First, consolidation would reduce the number of governmental entities providing municipal services in Des Moines, thereby eliminating some of the confusion over who provides what services.

Assumption would allow coordination of water services on a citywide basis rather than district-by-district, resulting in better comprehensive planning, improved coordination of construction activities, and enhanced management of development. Providing water as a City service allows certain savings, such as reduced administrative costs and shared use of equipment and manpower.

Assumption of water services would ensure that the City of Des Moines would be directly responsible for longrange water supply planning for all residents and businesses on a citywide basis. It would also allow the development of uniform extension policies, rates, connection fees, maintenance standards, fire flow storage, and construction standards. Currently, these practices vary among all three districts serving Des Moines. The report concludes that bringing water services into the City's scope of responsibility will make the provision of municipal services more efficient and less costly in the long run.

The report also examines the technical, legal, and financial costs associated with assumption. If after balancing potential benefits against costs, the City Council determines to proceed with assumption, an application would be filed with the King County Boundary Review Board. The Board reviews assumptions based on specific criteria outlined in State law and has the authority to approve, reject or modify an assumption.

16th Avenue South Slide Repair Project

During a major storm occurring Thanksgiving eve of 1998, a large landslide developed on the west side of 16th Avenue South at the road crossing of Massey Creek. This is located between the cross streets of Kent-Des Moines Road and S. 240th Street. The landslide exposed a major 16-inch high-pressure gas main and broke an eight-inch sewer main, causing raw sewage to spill into Massey Creek. An estimated 30-40 feet of a 4-foot by 4-foot concrete box culvert, that conveys Massey Creek under 16th Avenue, had also been washed out at the downstream end.

In addition, the stream grade from the box culvert had changed from a 6-foot drop (with a pool) to a condition where over 10 feet of slide debris had buried the outlet of the culvert. In order to temporarily stabilize the road and support the gas and sewer mains, over 120 concrete blocks were placed along the roadside. Subsequent evaluation of the condition of the culvert showed that it had collapsed in several locations and needed to be replaced.

The proposed repair includes the replacement of the existing concrete box culvert with a new 12-foot span by 6-foot high steel arch culvert. (Steel was chosen over concrete because of the cost and can be easily maneuvered around the critical road utilities). The new culvert will be better aligned with the creek channel, thereby reducing erosion at the inlet and outlet, and will be lengthened to better natch the grade of the stream. The size of the new culvert will provide for 100rear frequency storm and allow passage of fish. The existing culvert was a major fish passage barrier. Other elements of the project will be roadside drainage from the west shoulder of 16th Avenue to the creek and installing gabion (rock-filled steel baskets) headwalls at both ends of the culvert.

Due to the hazards involved with working around a high-pressure gas main, the size of the excavation, and the equipment needed to support the pipeline, it will be necessary to close the road between S. 240th Street and Kent-Des Moines Road. The project is expected to start in September and take between 3-4 months to complete. Following the installation of the culvert and making the road repair, 16th Avenue South will be re-paved from Kent-Des Moines Road to the southern limits of the culvert area excavation.

This project is being funded by Federal Emergency Relief Funds, the City of Des Moines Arterial Street Fund, Municipal Capital Improvement Fund and Surface Water Utility. Funds from the Midway Sewer District and Highline Water District are anticipated to partially cover costs of the street overlay, as required for restoring the road following the 16th Avenue water main break (that occurred earlier this year) and the proposed Midway Sewer District sewer bypass project (scheduled for this summer).
